#### MEMORANDUM OF UNDERSTANDING BETWEEN THE NATIONAL AIR TRAFFIC CONTROLLERS ASSOCIATION AND THE FEDERAL AVIATION ADMINISTRATION

This Agreement is made between the National Air Traffic Controllers Association ("NATCA" or "the Union"), and the Federal Aviation Administration ("FAA" or "the Agency"), collectively known as "the Parties." This Agreement represents the complete understanding between the Parties at Los Angeles Center concerning the 2026 Basic Watch Schedule (BWS).

Section 1. This Agreement applies to all employees in Area A for the leave year beginning January 11, 2026 and ending January 9, 2027.

### Section 8. The Parties have agreed to:

- a. Schedule overtime before preference.
- b. The 0530 shift, outside of Mid Shift requirements, will be assigned to the BUE who is highest in seniority for those on the associated crew who have indicated a desire to work the shift, if there are no volunteers on the crew, the 0530 shift will be rotated equitability.
- c. The following 9 and 7 hour shift start times in accordance with the Parties MOU:
  - a. Swing shift:
    - i. 9 hour in duration will start 1 hour earlier than bid line
    - ii. 7 hour in duration will start 1 hour later than bid line
  - b. Day shift:
    - i. 9 hour in duration will start at bid line time
    - ii. 7 hour in duration will start 1 hour later than bid line
  - c. Any additional 9-9-8-7-7 start times will be negotiated between the Area rep and the OM
  - d. The parties agree that there will be one 9-9-7-7-8 per set of RDO's. If staffing improves to allow more than one 9-9-7-7-8 during the year, then the parties will agree to meet per Article 7 of the contract.
  - e. The parties agree that the M2100 will have 30 min flex time.
    - i. Saturday evening M2100 shift will be no flex.
    - ii. S0530 can be flexed to 0515 prior to the mid.
  - f. The parties agree that all 0800 shifts will have a 30 minute flex.
  - g. The parties agree that all other flex times will be 15 minutes Per the ZLA Facility Art 32 MOU.

Section 9. This agreement shall expire on the last day of the 2026 leave year, January 9, 2027. Signed this 24 day of September 2025.
